Outside of work (during leisure time), the IGBCE protects its members with worldwide accident insurance cover. The IGBCE leisure time accident insurance is included in the membership fee.

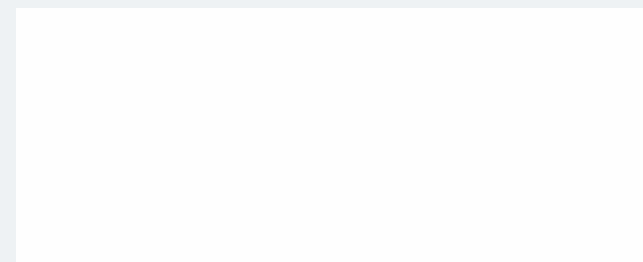
